1. We declare that the attached copies of documents are identical with the originals.
2. We declare that the reason of payment and date stipulated in this application correspond to the real business transaction for which the L/C is to be issued and are in compliance with the current legal regulations in Bulgaria.
3. We are aware of the penal liability that we are liable for, in accordance with Article 313 of the Penal Code for disclosure of misleading data and facts and in case of declaring untrue facts.
4. In case you will receive additional documents or papers, which are not required under this L/C, you are authorized to transmit these documents to us without checking – without taking notice of their content and without any responsibility on your side.

By signing, the present application for L/C issuing we unilaterally enter into the following engagements:

1. The Bank is entitled to issue L/C only upon presentation of duly filled application and all the documents required for the specific operation. The Applicant is obliged to provide, if requested by the Bank, supplementary information (financial and business documentation) for control purposes. The Applicant is obligated to inform the Bank about any event related to the present L/C.
2. In case an application under which further specifications are needed (concerning the wording, the amount, the documents required, the term of validity, the address of the beneficiary, the collateral proposed etc.) the issuance of the L/C may be postponed within 5 working days. After expiration of such term, if the necessary clarifications are not made, it is considered that the Applicant has ultimately withdrawn his consent and the application should be cancelled applying the respective commission as per the Bank's Tariff in force.
3. The Bank issues the L/C on Applicant's risk and responsibility. The Applicant declares simultaneously that he/she/it understands the meaning of letters of credit wording as instructed on his/her/its part, that he/she/it is bound irrevocably and undisputable by it, and gives an unconditional and irrevocable consent for payment under the relevant letters of credit, if a complying presentation is made. The Applicant declares that he/she/it shall have no claims towards the Bank in case of payment under the L/C upon complying presentation.
4. The Applicant shall indemnify the Bank for all commissions and expenses resulting from the execution of his application as well as any charges as a consequence of any court or out-of-court action in the country and abroad, and for this purpose gives the explicit consent for their ex officio collection from all accounts held with the Bank in his/her/its name. Independent from the security submitted, inclusive the cases when the L/C has been closed, the Applicant remains obliged to the Bank until covering all the charges and expenses of the Bank until the final indemnification by the relevant customer of the charges and expenses of the Bank concerning any payments in relation to the issuing, managing and accomplishment of the L/C.
5. The Applicant accepts indisputably that the commitment under the L/C issued is independent and separate from the engagement of the Applicant under the commercial /or other contractual/ relationship, and the Bank shall act with reasonable care upon examination of presented in utilization documents or extension of validity under its own discretion duly informing the Applicant.
