1. I am aware of and accept explicitly General Terms and Conditions of Online Banking for Tokuda Bank, the applied General Terms and Conditions for Payment Services and Conditions for the particular types of payment accounts, Tariff for Fees and Commissions of the Bank for its servicing and operations; I will promptly comply with Safety Recommendations and User Guide for Online Banking of Tokuda Bank, published on the Bank's website (<http://www.tokudabank.bg/>).

  - 6.1. Tokuda Bank AD shall bear no liability as to any illegal acts by third parties in relation to the SMS messaging service, or when mobile operator, the service provider shall not deliver in due time or shall not at all ensure the delivery of the SMS message; as well as when due to circumstances beyond Bank's control the SMS message shall not be sent, received respectively, or shall not receive in due time.
  - 6.2. In case of discrepancy in the amounts due by me on contracts for services rendered by Tokuda Bank AD as stated in the SMS message and those stated in documents issued by the Bank, the documents issued by the Bank shall prevail.
  - 6.3. I have the right to refuse the receipt of SMS messages at any time, by notifying Tokuda Bank in writing thereto; in this case i should provide Cloud qualified electron signature (CQES)for identification and authentication in connection with the provision of payment services through the Internet banking of Tokuda Bank.

I give my consent that a User authorised by me shall sign documents in the Online Banking in my name and at my expense (applicable only if the Request indicates "active access with payment document authorization rights" for a User) with by means of identification and authorization, username and password, PUK1 and PUK2, TAN via sms or Cloud qualified electron signature (CQES) as well as I agree that the User authorised by me shall be the User for other Clients of Tokuda Bank.(applicable only in case of authorization)
8. The information provided in relation to this Declaration is true, accurate and complete, and in case of change in any of the circumstances declared, I shall notify the Bank in writing

I am aware of the criminal liability under art. 313 of the Criminal Code and that under the effective legislation I shall be liable for any damages caused to the Bank by declaring untrue data.
